1. GENERAL INFORMATION

1. NC District Dues are \$12.00 per member per year. NC District Scholarship is \$2.00 per member per year.
2. Annual NC District Dues and NC District Scholarship are payable in two payments: One half before July 1st of each year and the second half before January 1st of the next calendar year.
3. Installment dues are payable as follows:
 - Dues= \$6.00/member per installment
 - Scholarship = \$1.00/member per installment
4. Likewise, it is always acceptable to pay NC District Dues and NC District Scholarship in full before July 1st of each year.
5. **EXCEPTION:** Dues and scholarship for new/reinstated members are prorated from the time of entrance into the club to the next semi-annual payment. Prorated NC District Dues would be equal to \$1.00 per month until the next semi-annual payment. Additionally, \$1.00 for Scholarship would be payable for the new member.
6. It is the duty of the retiring club treasurer to complete the first report and remit check to the incoming NC District Treasurer before passing the books to the new club treasurer.
7. NC District Dues and NC District Scholarship should be remitted with separate checks.
8. Checks should be made payable to NC District Pilot International.
